3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- 3.4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

 - (vi) bidding with the intention not to win the bid.
- H. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
- I. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

4.1 BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4.2 SCOPE OF WORK (TERMS OF REFERENCE)

SANSA requires the services of a design and communication agency or publication house to edit, design, print and delivery of 2 books as detailed below.

Specifications: Book 1: Spot 12 Years' of Satellite Observation Coffee Table Book.

- Copywrite, edit, design and print 200 copies of the book that has a maximum of 100 pages - with consideration of the SANSA Corporate Identity guidelines:
 - Full colour A4 portrait layout.
 - Edit content to ensure a digestible read (content to be written from existing reports.)
 - Impactful very high resolution satellite images will be provided
 - Design concept to be agreed with SANSA
 - A printed gloss Hard Cover with silver foiled SANSA logo and title
 - Hardcover background to be full color satellite image.
 - Text and imagery printed full color plus overall machine varnish throughout and folded
 - Internal pages of 150gsm
 - Collated, section sewn made up with hard cover
 - Book to be made available as an e-book.

5. EVALUATION CRITERIA

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below

Quality/Functionality:

Scores will be tabulated to 100 points. Respondents must score **70 points** and over to be assessed on their financial offer and preference score.

The allocation of points for the evaluation of quality/functionality is set out in Table3 below:

Evaluation criteria 1: Provision of previous samples

The service provider must submit at least three (3) samples of coffee table books (2 samples) and corporate publications (1 sample) developed by the proposed project team. Submission of any other printed documents will not be evaluated. Submission of less than three (3) relevant samples will result in a loss of 10 points.

Evaluation criteria 2: Project Team Experience

The experience of the service provider's key personnel in similar industry related projects or similar areas and conditions in relation to the scope of work will be evaluated - **CV's or individuals' profiles must be submitted**. The account project manager must have the required skills. **Failure to submit CV's and portfolio of experience of the science writer, editor and graphic designer will result in loss of 10 points per required team resource (science writer, editor and graphic designer) whose CV is not attached.**

The bidder must present at least provide 3 valid reference letters (on client's letter-head) from companies for which they have provided similar services. Letters must indicate the periods in which such services were rendered.

Failure to provide all 3 reference letters will result in a score of zero in this category/criterion

The experience of the tenderer (company) in similar projects or similar areas and conditions in relation to the scope of work will be evaluated.

The scoring of the company experience will be as follows:
